AGREEMENT and Waiver/Release of Liability – ALL REGISTRANTS MUST READ AND SIGN

I understand that running/walking is a potentially hazardous activity and that I attend the Born to Run 5K out of my own free will and choice. In choosing to attend this Run/Walk and any related events, I fully accept and assume all risks, whether before, during, or after the Run/Walk. All risks are known and appreciated by me. I waive any and all specific notice of the existence of the risks. I shall assume and pay my medical and emergency expenses in the event of injury, illness, or other incapacity regardless of whether I authorized such expenses. I realize that this Run/Walk requires physical conditioning and I represent that I am in sound medical condition capable of participating in the Run/Walk without risk to others or myself. I will Run/Walk safely within the limits of the law, my own abilities, my equipment, and the external conditions and in a manner so as not to endanger either others or myself. Knowing these facts and in consideration of my entry acceptance, admission to and/or participation in the Run/Walk and its related events, I, for myself and anyone acting on my behalf, release, waive, and discharge any and all claims, demands, and actions of any and every kind I have, or may hereafter accrue against the Woman's New Life Center (WNLC) and the event directors, sponsors, and volunteers directly or indirectly arising out of or relating in any respect to my attending or participating in the Run/Walk. My waiver and release of all claims, demands, actions, and liability shall include without limitations, any injury, damage, or loss to my person or property which may be (a) caused by any act, or failure to act, by the above identified persons and entities or (b) sustained by me before, during, or after the Run/Walk and its related events. I agree to abide by all rules and regulations. I understand that the WNLC may use my name, photograph, and/or likeness in promotional or advertising materials. I consent to such uses and waive any rights of privacy or publicity I may have in connection with those uses. I further agree to indemnify and hold harmless the parties released above from any and all losses, damages, claims, and expenses, including attorney's fees, arising from or relating in any respect to my participation in the Run/Walk or my breach of this agreement.
